Dear Ms. Colak,

It gives me great pleasure to inform you that our Graduate Studies Committee has approved your application for the University of Chicago Law School's 2018-2019 LL.M. Program. As one of the people who read your application, I am particularly pleased to be the first to congratulate you on your admission. We are delighted that you chose to apply to Chicago.

Our orientation program will begin on September 24, 2018, classes will begin on October 1, 2018, and graduation will be on June 15, 2019. As a full time student, you will be required to take at least nine credit hours (three courses) each of the three academic guarters for a total of at least 27 credit hours for the degree. All of our classes are conducted in English. The curriculum available to you while you are here will include about 170 courses, seminars and workshops.

With a total student body of approximately 650 students, Chicago is one the smallest of the national law schools in this country. Our facilities and curriculum have been designed to take advantage of our size by promoting close working relationships among classmates and between all students and faculty. In reviewing applications, we look for indications that candidates will be active and engaged in the intellectual and social life of the Law School. Thus, admission to our LL.M. program is a tribute not only to your impressive accomplishments, but also to your personal characteristics that we feel will enrich our community.

I know you would find Chicago a wonderful place to pursue the LL.M. degree. Our program is small - about 75 people each year - and that creates a real sense of community among the students. We also make extra efforts to insure that LL.M. students have lots of contact with faculty and our J.D. students. Unlike many schools with substantially larger LL.M. programs, this is not a place where LL.M. students tend to isolate themselves with other students from their own country or region. Chicago offers an academic environment that encourages intellectual engagement both in and outside the classroom, and the social and cultural opportunities of a great city. If that sounds like an attractive environment to you, I hope you will decide to join us in September.

Listed below is the Law School budget for LLM students during the 2017-2018 academic year. The budget for 2018-2019 will be available in late April.

*All law students are required to have acceptable medical insurance coverage. Students do not have to join the University's plan if they provide evidence of comparable coverage under their own plan.

The University sends tuition and fee bills before the beginning of each of the three academic quarters. Each bill covers one-third of the total annual tuition/fee charge. The bills are payable in late September, late December, and late March.
